2) After careful consideration of the proposal of the Superintending Engineer/ Coimbatore Electricity Distribution Circle/ Metro, sanction is hereby accorded for the creation/ abolition of the following posts in various cadres as detailed in the Annexures for a period of one year from the date of utilisation, due to revised workload norms in respect of RWE posts in O&M Distribution Sections (Field Workmen), Revenue Accounting posts, Assessment-cum-Collection posts, Stores staff, Lines, Sub-Stations, Special Maintenance, MRT, etc., based on the Services/ Transformers as on 01.01.2014 and due to regularisation of 3 Nos. upgraded Sections being utilised, the vacant 3 posts of AE/JE (Electrical) I Grade be abolished in O&M Sections in Coimbatore EDC/ Metro.
