PROCEEDINGS:

In the proceedings read above, orders have been issued modifying the pay band in respect of Superintendent-Cum-Stenos of Administrative/ Technical Branches on par with the Superintendents of the said Branches, by conferring them with class-II status. Hence, a proposal to make amendments to Regulation 17,88,92,93,94 and 105 of Tamil Nadu Electricity Board Service Regulations has been placed before the Board of TANGEDCO. After careful examination, the Board has resolved to amend the said regulations suitably.

2. Accordingly, in exercise of the powers conferred by section 79 (c) of the Electricity (Supply) Act, 1948, (Central Act 54 of 1948), read with section 185 of the Electricity (Supply) Act, 2003 and G.O.Ms.No.100, Energy (B2) Department, dated 19.10.2010, the Tamil Nadu Generation and Distribution Corporation Limited (formerly Tamil Nadu Electricity Board) makes the following amendments to the Tamil Nadu Electricity Board Service Regulation:-

AMENDMENTS

In the said Regulations,

(I) in regulation 17,

- a) the sub-regulation (c) shall be substituted as below:-
“(c) The age of retirement on superannuation of the employees of the Board belonging to the categories of supervisory staff to whom the Industrial Employment (Standing Orders) Act, 1946 does not apply, shall be 58 years”

::2::

b) the sub regulation (d) shall be substituted as below:-

"(d) The age of retirement on superannuation of persons employed in the managerial or administrative posts or supervisory posts to whom the Industrial Employment (Standing Orders) Act, 1946 does not apply, shall be 58 years".

(II) in regulation 88,

(a) under the heading "CONSTITUTION", in CLASS-II" in "DIVISION-IX", after the expression "Category-2(a)" in Column (1) and the corresponding expressions in Column (2) thereof, the following expressions shall respectively be inserted, namely:-

"Category-2(b) Superintendent-Cum-Steno";

(b) in "CLASS-III" in "DIVISION VII-A, relating to "BOARD OFFICE ADMINISTRATIVE AND TECHNICAL BRANCHES", after "Category 2: Assistant", the following category shall be added, namely:-

"Category-2(a) Assistant-Cum-Steno";

(III) in ANNEXURE-I (Referred to in Regulation 92),

(a) Under the heading "CLASS-II" under the sub-heading "DIVISION-IX", after the expressions "Category 2(a)", in Column (1) and the corresponding expressions in Columns (2) and (3) thereof, the following expressions shall respectively be added, namely:-

"Category-2(b)	Superintendent-Cum-Steno	Promotion from Assistant-cum-Steno in Category-2(a), in Division-VII-A, of Class-III";

(b) Under the heading "CLASS-III" in DIVISION VII-A, relating to "Board Office Administrative and Technical Branches", after the expressions "Category 2: Assistants", in Columns (1) and (2) respectively and the corresponding expressions in Column (3) thereof, the following expressions shall respectively be added, namely:-

"Category-2(a)	Assistant-cum-Steno	Promotion from Steno-Typist in Category-4 of this Division;

(IV) in ANNEXURE-II (Referred to in Regulation-93)

- a) under the heading "Class-II service", after the expression "1(o).Superintendent" in column (1) and the corresponding expressions in Column (2) thereof, the following expressions, shall respectively be added, namely:-

"1(p) Superintendent-cum-Steno	Senior Personnel Officer"

- b) under the heading "Class-III service" in "Division VII-A, relating to "Board Office Administrative and Technical Branches", after the expressions "27. Assistant" occurring in Columns (1) and (2), the following expressions, shall respectively be inserted, namely:-

"27(a)	Assistant-cum-Steno"

(V) in ANNEXURE-III (Referred to in Regulation-94),

- a) after the expression "Superintendent" in Column (1) and the corresponding expressions in Columns (2) and (3) thereof, the following expressions shall respectively be inserted, namely:-

"Superintendent - cum-Steno	Recruitment by Promotion	(1) Must posses the Minimum General Educational Qualification (2) Must have passed the Government Technical examination in Typewriting by the Senior Grade both in English and Tamil and have passed the Examination in Shorthand Senior Grade both in English and Tamil. (3) Must have rendered not less than 10 years of service both as Steno-Typist and Assistant-cum-Steno."

- b) after the expression "Assistant Librarian" in Column (1) and the corresponding expressions in Columns (2) and (3) thereof, the following expressions shall respectively be inserted, namely:-

"Assistant-Cum-Steno	Recruitment by Promotion	<ol style="list-style-type: none">1. Must possess the Minimum General Educational Qualification.2. Must have passed the Government Technical examination in Typewriting by the Senior Grade both in English and Tamil and have passed the Examination in Shorthand Senior Grade both in English and Tamil.3. Must have passed TANGEDCO Test for Sub-ordinate Officers.4. Must have rendered not less than 5 years of service as Steno-Typist."

(VI) in ANNEXURE-IV (Referred to in Regulation-105),

under the heading "II. Employees in Class II Service, after the expression "Superintendent" in Column (1), the expression "Superintendent-Cum-Steno" shall be inserted".
