PROCEEDINGS:

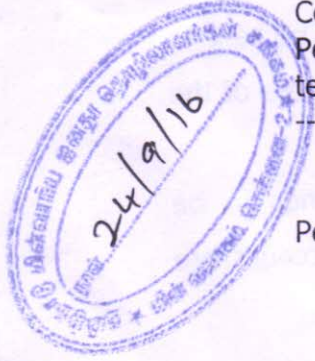
In Board's Proceedings first and second cited orders were issued for adopting the CPS Scheme introduced by the Tamil Nadu Government in G.O.Ms.No.259 Fin (Pen) Department, dated.6.8.2003.

2. In respect of death while in service orders were already issued in the reference third cited directing the CEs/SEs/Officers concerned to pay the employee as well as Employer Contribution together with interest to the Legal Heirs by adopting the instructions of the Government of Tamil Nadu .

3. In the reference fourth cited orders have been issued by the Government of Tamil Nadu for the settlement of accumulations under CPS Scheme in respect of CPS Subscribers who retired/died/resigned and terminated from the services after obtaining an undertaking.

4. Accordingly in exercise of the powers conferred by Section 79 (c) of the Electricity (Supply) Act, 1948 (Central Act 54 of 1948) read with section 185 of the Electricity supply Act 2003, the TANGEDCO/TANTRANSCO (formerly known as TNEB) hereby ordered to settle the accumulations under CPS in respect of retired/resigned/died and terminated employees after obtaining necessary undertaking from them by the CEs/SEs and Officers concerned.

5. The CEs/SEs/Officers concerned are instructed that before making the final settlement under CPS, the bills along with the CPS dockets shall be sent to the territorial DCIAOs to issue authorization after checking the correctness of the payment.


