Sub: TANGEDCO – Fixation of pay on appointment by Internal Selection – Allowing Grade Pay – Permitting Revised option - Orders – Issued.

In the Board's Proceedings first cited, orders were issued for allowing protection of pay to the employees on appointment by internal selection.

- 2) In the Board's Proceedings second and third cited orders were issued for revision of Pay and Allowances to the employees and officers of TANGEDCO with effect from 01.12.2007. The revised pay of the employees were fixed with Pay Band and Grade Pay instead of the time scale of pay.
- 3) In the reference fifth cited, orders have been issued duly cancelling the orders issued in the reference forth cited, by allowing the benefit of applicable Grade Pay to the employees appointed through internal selection post duly protecting the pay drawn in the previous post by fixing the minimum of the pay band and then the balance amount as personal pay. The above order has been given effect from 01.12.2007 or on the date of appointment through internal selection after 01.12.2007 notionally and with monetary benefit from 09.01.2014.
- 4) Consequent on the clarification issued in the reference fifth cited, the employees covered under this order have requested for revising their option to get the beneficial fixation.
- 5) The above request was examined in detail. After careful consideration, the TANGEDCO hereby ordered that the employees appointed through internal selection on or after 01.12.2007 and their pay refixed consequent on the Boards Memo. dated 19.11.2014 be permitted

to revise their Wage Revision option from the date of internal selection to the date of Wage Revision i.e., 01.12.2007 (or) 01.12.2011 as a special case and also be permitted to revise their Wage Revision option. The revised fixation will be given notional effect from the date of refixation and with monetary benefit from 09.01.2014 as ordered in the reference fifth cited.

- 6) The revised option once exercised shall be final. If no revised option is exercised within the period of two months from the date of issue of this order, their pay fixation allowed with reference to the original option will stand.
- 7) The Chief Engineers/Chief Financial Controllers Superintending Engineers/Deputy Secretaries/Chief Internal Audit Officer and other officers will arrange to display a copy of this Memo. conspicuously in the notice Board of the Offices under their control.
