Sub : TANGEDCO – Preperation of panel for promotion of employees – different norms adopted between the class I service by the Secretariat Branch and Class II & III service by the Administrative Branch – intervention for adopting a uniform procedure by both the Branches requested.

We would like to bring to your kind notice the following procedures being adopted by the Board Office Secretariat Branch and the CE/Personnel Office Administrative Branch while preparing the Panel for promotion of employees to the post of Deputy Financial Controller ( Class I service ) and the Accounts Officer ( Class II Service )

Reference No. 1 to 4 relates to the promotion for AAO's.

Reference 5 relates to promotion for DFC's.

As per B.P.M.S.( Ch) No.182, dated 18-05-1987 *the* crucial date for preperation of panel to the post of DFC is 1<sup>st</sup> May.

As per B.P.M.S.( Ch) No.212, dated 12-06-1987 *the* crucial date for preperation of panel to the post of AAO and A.O is 25<sup>th</sup> March and 20<sup>th</sup> April respectively.

Among many others the following 3 employees names were deferred in the earlier Panel covered in (per) CMD / TANGEDCO Proceedings No.7, Adm.Branch, Dated 08-02-2011 due to their OUS qualification and subsequently considered in the panel covered in (per) CMD / TANGEDCO Proceedings No.29, Adm.Branch, Dated 23-03-2013.

As per the Hon'ble High Court order dated 27-06-2012 in W.P No.7276 to 7278 of 2012, that for the limited purpose of exemption from passing departmental examinations OUS degrees can be considered.

- 1) P.Vasantha / Pudukottai / EDC
- 2) N.Ramachandran / Thirumakottai / KGTPS
- 3) C.Vasugi / Ramnad / EDC

Based on the representations of the employees and their trade unions to restore their original seniority as their Juniors have already been promoted as Accounts Officers and DFC's, the Board was very kind enough to order in CEP / Memo No. 029119/266/G30/G301/2013-4, Dated 12-02-2014. That their inter -se- seniority be fixed in the rank indicated against the names and included in thee panel communicated in (per) CMD / TANGEDCO Proceedings No.7, Adm.Branch, Dated 08-02-2011.

- 3) Tmtty.S.UshaDevi, Virudhunagar / EDC, D.O.J. 06-08-2014.

Not working as Accounts Officers as on the Crucial date 01-05-2014, have been promoted as Deputy Financial Controllers duly taking into account of their Juniors already been promoted and working as Deputy Financial Controllers.

Unfortunately the ADM Branch is ignoring the fact that Juniors already promoted as A.O. in the earlier Panel and are working as Accounts Officers for a long time there by defeating the very objective of giving inter-se-seniority to the senior employees.

The belated promotion of the Seniors is not due to their fault, but only due to the belated decision taken by the Administration in the matter of considering the employees possessing OUS qualification for promotion.

In the above circumstances we kindly request the Respected Chairman to intervene in the matter immediately, advise the ADM Branch to follow the correct procedure being adopted by the Secretariat Branch, promote the Seniors as Accounts Officers with appropriate seniority and thus render justice to the aggrieved employees.
