PROCEEDINGS:

The Pensioners' Associations have represented for payment of Interim Relief due to the delay in revision of pension/family pension to the pensioners/family pensioners of Tamil Nadu Generation and Distribution Corporation.

Considering the representations of the Pensioners' Associations, Tamil Nadu Generation and Distribution Corporation direct that the pensioners/family pensioners as on 01.10.2017 be paid an interim relief of Rs.1,250/- (Rupees One Thousand, Two Hundred and Fifty only) per month and the arrears of Rs.5,000/- from October 2017 to January, 2018 be paid in one lumpsum on **03.02.2018**.

3. The above said amount is adjustable against the benefits of the revision of pension due with effect from 01.01.2016 and fixation of pay in the revised pay matrix due from 01.12.2015.

4. The expenditure sanctioned in para 3 above is debit to Tamil Nadu Electricity Board Account Code No.75.404 Consolidated lump sum Interim arrear payment.
