**PROCEEDINGS:-**

Following the orders of the Government in the Government Order first read above, orders have been issued that an officer/employee of TANGEDCO whose increment falls due on the day following superannuation, on completion of one full year of service which are countable for increment under regulation 36 (a) of Tamil Nadu Electricity Board Service Regulations, be sanctioned with one notional increment at the rate as described under regulation 6 of TANGEDCO Revised Pay (Workmen) and (officers) Regulations, 2011, purely for the purpose of pensionary benefits and not for any other purpose – vide the proceedings second read above. Now, the Government in Government Order third read above, have issued amendment to rule 26 of Fundamental Rules. Regulation 36 of Tamil Nadu Electricity Board Service Regulations is corresponding to rule 26 of Fundamental Rules of Tamil Nadu. Therefore, the proposal for making amendments to the said regulations based on the orders issued by the Government in its Government Order third read above, has been considered and approved by the Board of TANGEDCO.

2. Accordingly, in exercise of the powers conferred by Section 79 (C) of the Electricity (Supply) Act, 1948 (Central Act 54 of 1948), read with Section 185 of the Electricity (Supply) Act, 2003 and G.O. Ms.No.100 Energy (B2) Department, dated 19.10.2010, the Tamil Nadu Generation and Distribution Corporation Limited (Formerly Tamil Nadu Electricity Board) makes the following amendments to the Tamil Nadu Electricity Board Service Regulations:-

**AMENDMENT**

In the said Regulations, after regulation 36, the following regulation shall be inserted:-

"36 (A) – an employee, who retires on or after the 31<sup>st</sup> December 2014 and whose increment falls due on the next day following the date of superannuation, on completion of one full year of service which is countable for increment under regulation 36, shall be sanctioned with one increment at the rate of 3% of Pay + Grade Pay, notionally on the afternoon of the date of retirement, purely for pensionary benefits only".

3. The receipt of these proceedings shall be acknowledged.
