In the reference first cited, orders were issued constituting a Grievance Redressal Committee at Regional Level consisting of an Executive Engineer, an Accounts Officer and an Administrative Officer to hear the Pensioners' Grievance once in three months and to take necessary action for the redressal of the grievances heard as per the rules in force.

2. In the reference second cited, orders have been issued to include the Regional Deputy Chief Internal Audit Officer/Audit Party to attend the Pensioners' Grievance Redressal Committee Meeting.

3. Now, the Pensioners' Associations have requested for the constitution of a committee at State Level for periodical discussion with the Pensioners' Associations for redressal of their grievances.

4. After careful consideration, it is hereby ordered to constitute a committee at State Level, with the following members;

- 1) Secretary/TANGEDCO,
- 2) The Chief Engineer/Personnel,
- 3) The Chief Internal Audit Officer/Audit Branch,
- 4) The Chief Financial Controller/General

The committee will hear the Grievance of the Pensioners' Associations mentioned in the Annexure periodically, once in four months and to take necessary action for the redressal of the grievances heard as per rules in force.
