In furtherance of the order issued under reference fifth cited, it is hereby ordered that for the purpose of considering promotion to the post of Commercial Inspector or Line Inspector from the post of Commercial Assistant or Wireman, the experience of five years in the type of work concerned shall be followed instead of five years in the post of Commercial Assistant or Wireman alone.

2) Further, in case of the promotion panel that would have been drawn for the crucial date October/November 2015 but could not be operated after June 2016 due to instructions from Head Quarters.

- a) For the post of Line Inspector and Commercial Inspector the pending panels shall be redrawn and operated subject to the condition stated in the above para (1) above.
- b) For the rest of the posts the pending panels shall be considered for operation in the first instance. Thereafter, a fresh panel shall be drawn for the year 2017 after drawing a Nil panel for the year 2016 to those posts.
